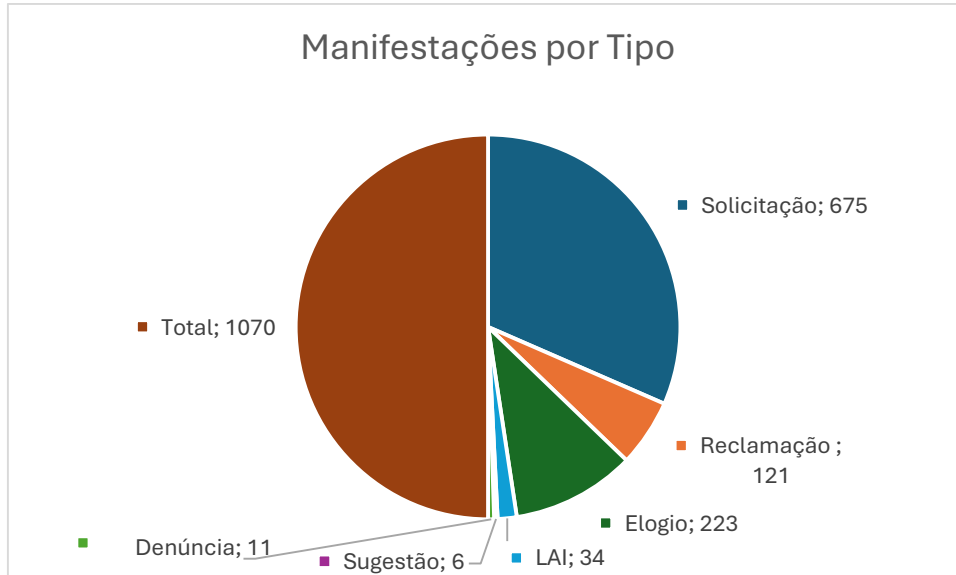

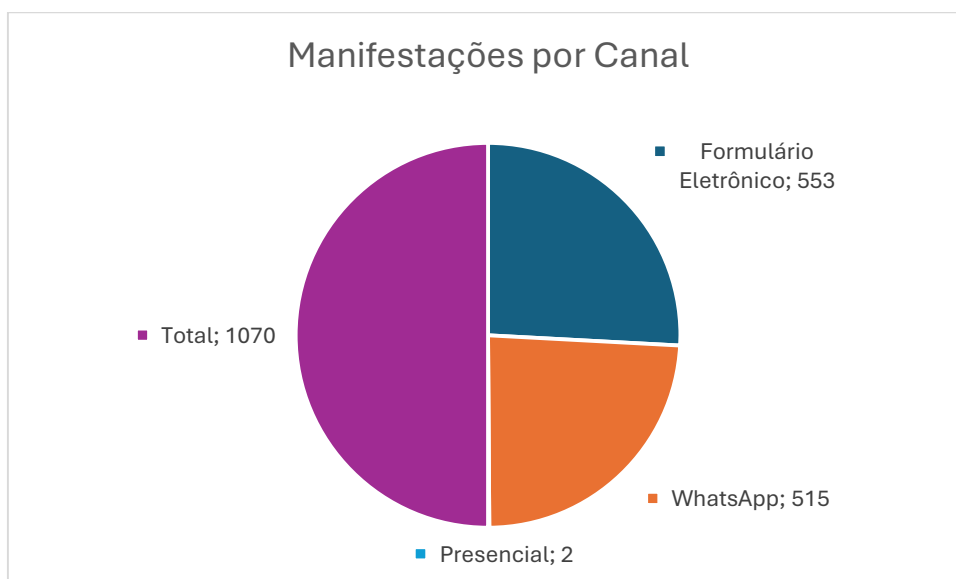

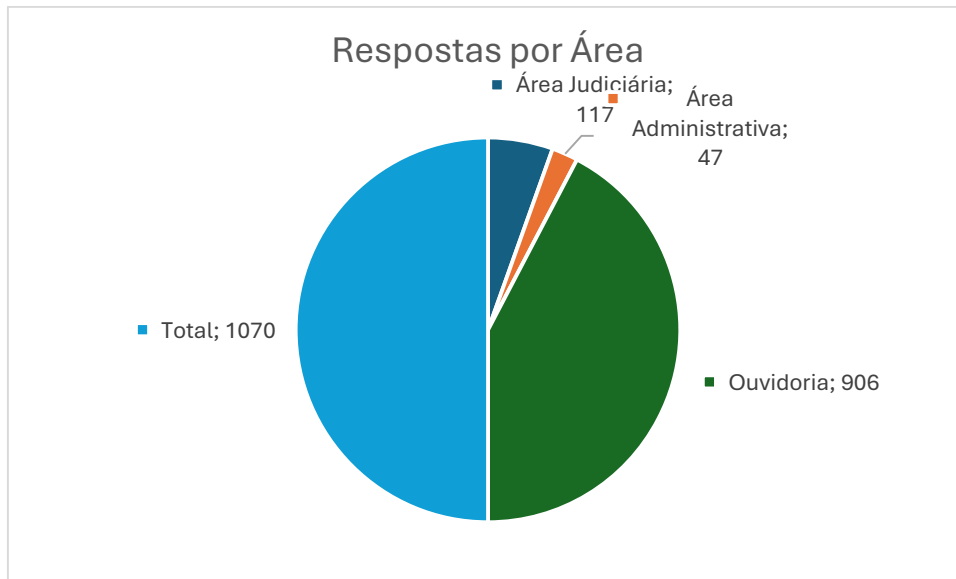
MANIFESTAÇÕES POR TIPOLOGIA



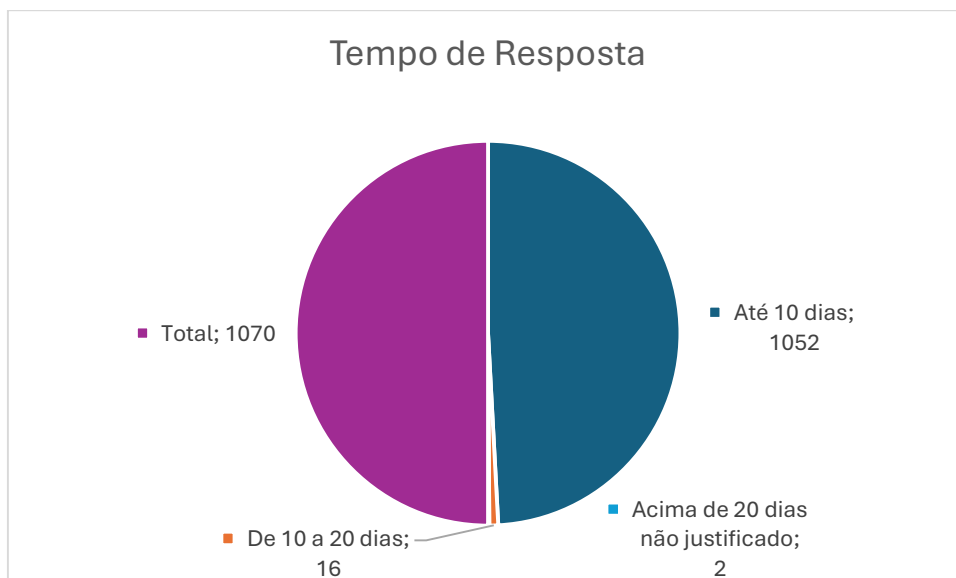
CANAIS DE ATENDIMENTO



RESPOSTAS ÀS MANIFESTAÇÕES POR ÁREA

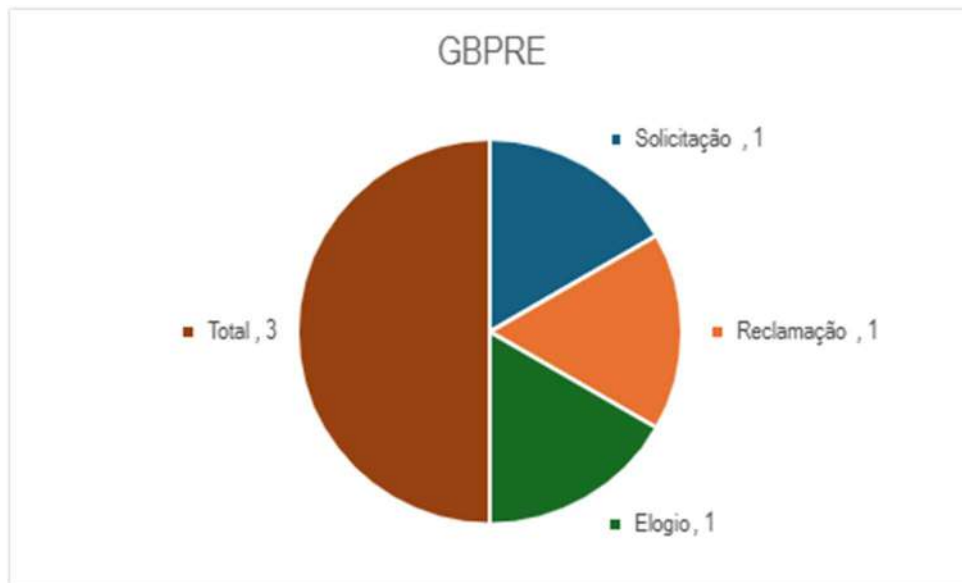


TEMPO DE RESPOSTA ÀS MANIFESTAÇÕES

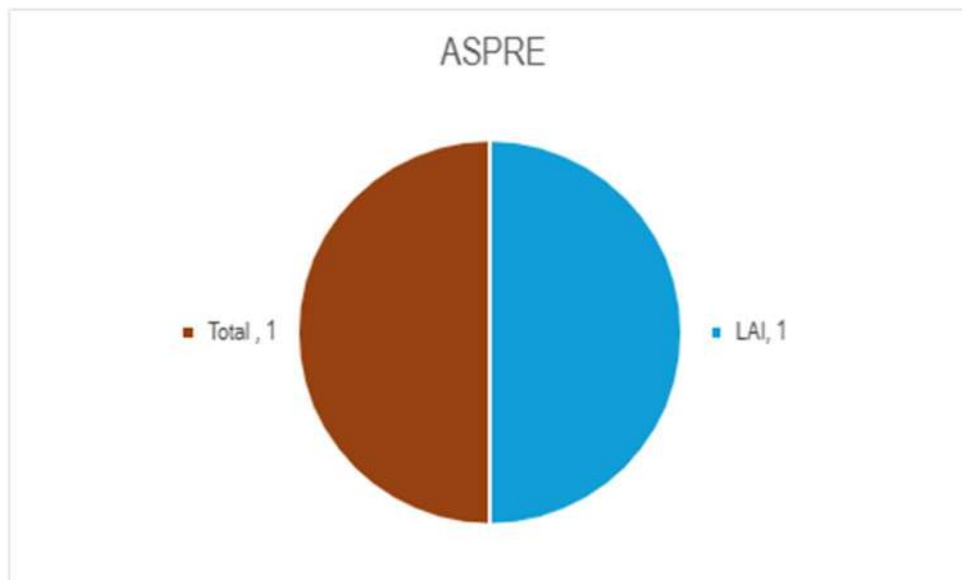


DISTRIBUIÇÃO DAS MANIFESTAÇÕES POR UNIDADES

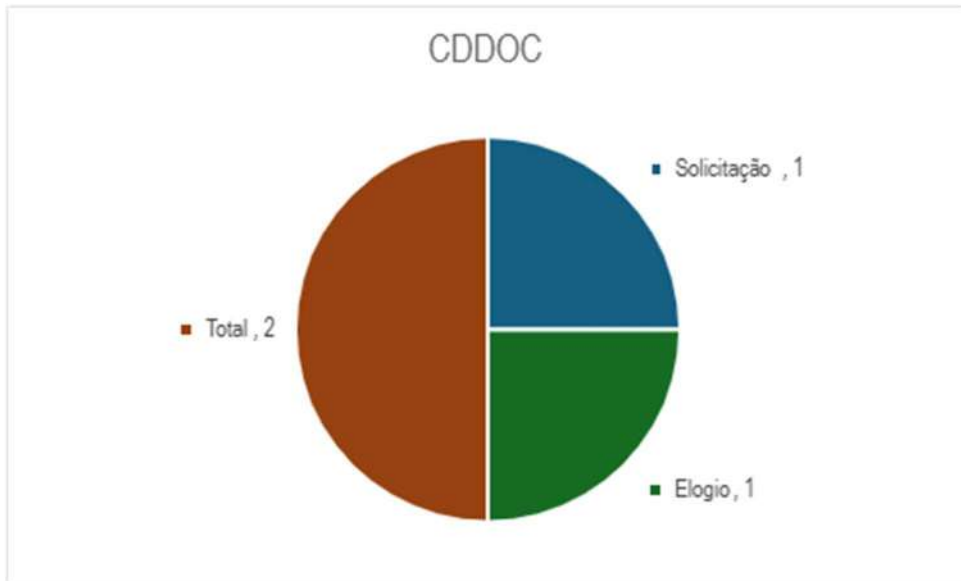
